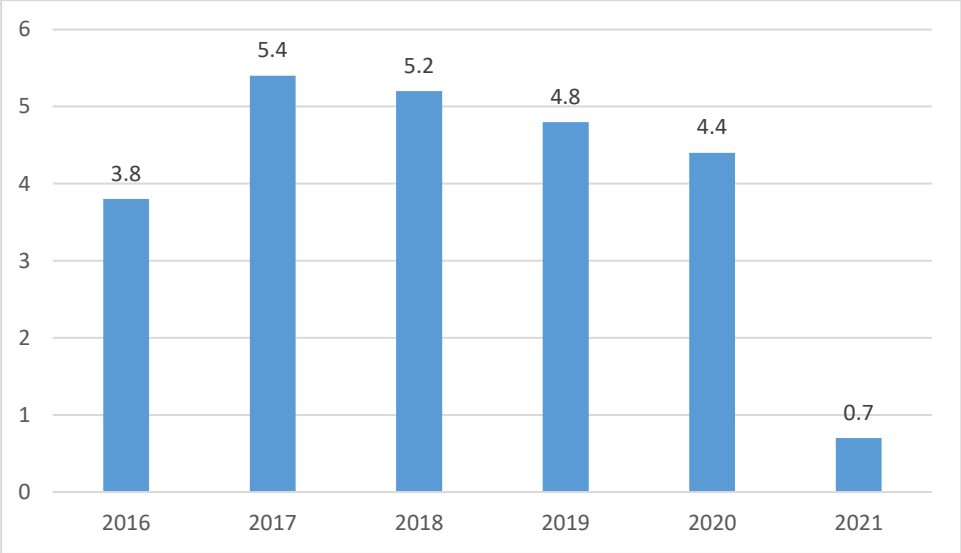

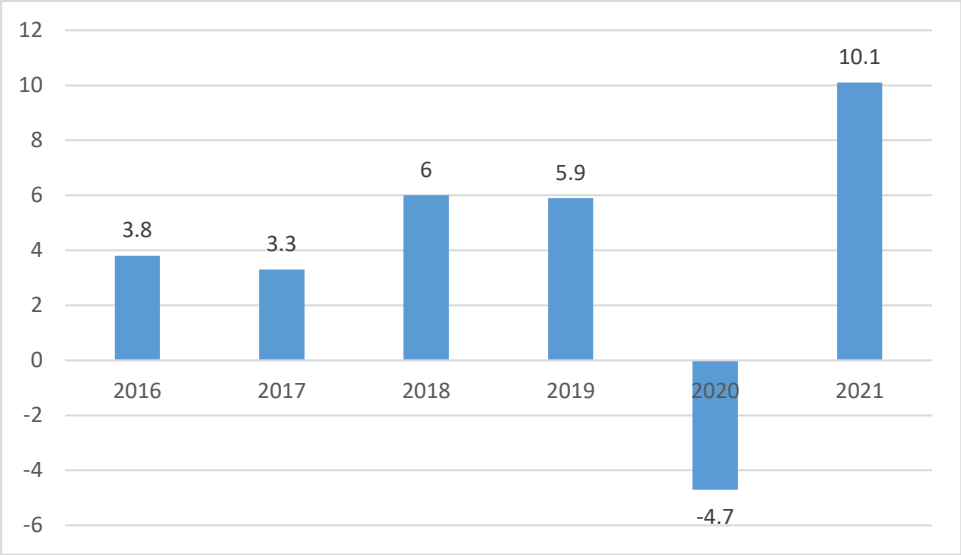
**1.0 Economic performance**

This report presents the economic performance for the first and second quarters of 2021. Economic growth decelerated in the first quarter of 2021 to 0.7 per cent compared to 4.4 per cent in the corresponding quarter of 2020, mainly owing to the onset of COVID-19 pandemic in the country in March 2020. On the other hand, real GDP grew by 10.1 per cent in the second quarter of 2021 compared to a contraction of 4.7 per cent in the same quarter of 2020. During the second quarter of 2021, the performance was supported by rebounds in most economic activities from significant contractions in the second quarter of 2020. The growth recorded was mainly as result of easing of COVID-19 containment measures that facilitated gradual resumption of economic activity. Some of the sectors that supported overall growth in the second quarter included Manufacturing (9.6%), Education (67.6%), Transportation and Storage (16.9%), Information and Communication (25.2%) and Other Services Activities (20.2%). Figure 1 and Figure 2 show the quarterly GDP for the first and second quarters, respectively, for the period 2016-2021.

Macroeconomic indicators pointed to the need to cushion economy from shocks related to the COVID-19 pandemic, which has continued to ravage most sectors of the economy. The Kenyan Shilling depreciated against all major international trading currencies except the Japanese Yen in the second quarter of 2021 compared to the same quarter of 2020. On average, the Kenyan Shilling ceded ground against the Pound Sterling, Euro and the US Dollar by 13.9 per cent, 10.8 per cent and 1.2 per cent, respectively, during the second quarter. However, the Shilling gained notably against all the regional currencies except the South African Rand. Central Bank Rate (CBR) remained at 7.00 per cent in the first and second quarter of 2021. Broad money supply as at June 2020 increased from KSh 3,890.0 billion to KSh 4,133.8 billion as at June 2021. Slowdown in economic activity was manifest in reduced activity at the Nairobi Securities Exchange (NSE). The NSE 20 Share index dropped from 1,942.1 points in June 2020 to 1,927.5 points in June 2021. Inflation increased from an average of 5.31 per cent in the second quarter of 2020 to 5.98 per cent in the corresponding quarter of 2020 mainly on account of significant surge in prices of agricultural produce due to the unfavourable weather conditions. Current account deficit on the other hand expanded by 28.2 per cent from KSh 85.9 billion in the second quarter of 2020 to KSh 110.1 billion in the corresponding quarter of 2021.

**2.0 Sectoral Analysis**

**Agriculture, Forestry and Fishing**

There was a slowdown in performance of agriculture, forestry and fishing activities in the first and second quarters of 2021. The sector is estimated to have contracted by 0.9 per cent in the second quarter of 2021 compared to a growth of 4.9 per cent in the corresponding quarter of 2020. The sector's

performance was cushioned from a steeper slump by a notable increase in milk production, horticultural exports and production of sugarcane. The volume of milk intake by processors increased by 37.9 per cent to stand at 208.5 million litres in second quarter of 2021. Cane deliveries increased from 1,666 thousand metric tonnes in the second quarter of 2021 to 1,907 thousand metric tonnes in the review period. Similarly, the volume of vegetables, cut flowers and fruit exports increased by 58.1 per cent, 55.2 per cent and 23.5 per cent, respectively, in the second quarter of 2021. Performance of the agricultural sector was further aggravated by significant decline in tea production from 143,037 metric tonnes in the second quarter of 2020 to 133,090 metric tonnes in the corresponding quarter of 2021.

### **Manufacturing**

Manufacturing sector's real GDP grew by 9.6 per cent in the second quarter of 2021 compared to a contraction of 4.7 per cent in the same period of 2020. The food sub-sector expanded by 6.7 per cent during the review period. Manufacture of dairy products; manufacture of bakery products; manufacture of tobacco products; registered a substantial growth. Production of non-food products rose by 12.2 per cent in the second quarter of 2021. This was evident in assembly of motor vehicle that grew by 10.0 per cent, manufacture of galvanized iron sheets (34.5%) and manufacture of paper and paper products (13.5%). Credit advanced to enterprises in manufacturing activity declined by 0.9 per cent to stand at KSh 1,265.8 billion in the second quarter of 2021.

### **Construction**

Performance of this sector was relatively slower in the second quarter of 2021 compared to the corresponding quarter of 2020. The sector recorded a growth of 6.5 per cent in the second quarter of 2021 compared to 8.2 per cent growth in the second quarter of 2020. Cement consumption increased by 29.3 per cent to 2,078.8 thousand metric tonnes in the second quarter of 2021, pointing to sustenance of performance in economic activities in the sector. Credit advanced to construction sector declined by 1.7 per cent to KSh 359.1 billion in the second quarter of 2021.

### **Electricity Supply**

Electricity and Water Supply sector grew by 5.2 per cent in the second quarter of 2021 compared to a 4.7 per cent contraction in the second quarter of 2020. Total electricity generated increased from 2,634.9 million kilowatt hour in the second quarter of 2020 to 2,975.8 million kilowatt hour in the quarter under review. The increase in electricity generation was notable from all sources except geothermal. Electricity generated from both thermal and wind expanded by about 69.0 per cent in the second quarter of 2021 compared to

a contraction of 64.9 per cent and 29.3 per cent, respectively, in the same quarter of 2020. Electricity generated from hydro increased by 4.6 per cent to stand at 994.9 million kilowatt hour in the second quarter of 2021.

### **Transportation and Storage**

Transportation and Storage sector reported a growth of 16.9 per cent in the second quarter of 2021 compared to a contraction of 16.8 per cent in the corresponding quarter of 2020. The accelerated growth was as a result of lifting of restrictions on domestic and international movement which was in place in the second quarter of 2020. Freight movement through Standard Gauge Railway (SGR) increased by 25.9 per cent to stand at 1,326 thousand metric tonnes in the second quarter of 2021. The number of visitor arrivals increased from 527 in the second quarter of 2020 to 113,307 in the quarter under review. Similarly, passenger transport through SGR increased from 6,363 passengers in the second quarter of 2020 to 304,445 passengers in the second quarter of 2021. Consumption of light diesel expanded by 27.4 per cent compared to a contraction of 22.4 per cent in the corresponding quarter of 2020.

### **Accommodation and Food Service Activities**

Accommodation and Food Service activities recorded a gradual rebound from a consistent contraction reported in the last three quarters of 2020. The sector grew by 9.1 per cent in the second quarter of 2021 compared to 56.8 per cent contraction in the second quarter of 2020. This sector was the most hit by the COVID-19 pandemic in 2020. One of the measures put in place to combat the pandemic was cessation of movement and in some regions. This culminated into a significant decline in number of visitor arrivals by over 99 per cent, scaling down of hotel operations and in some cases closure of some facilities in the second quarter of 2020. However, this improved tremendously in the review period after relaxation of most of the restrictions.

### **Financial and Insurance Activities**

Financial and insurance activities accelerated in the second quarter of 2021 to grow by 9.9 per cent compared to a growth of 4.4 per cent in the same period of 2020. Broad money supply (M3) expanded from KSh 3,890.0 billion as at end of June 2020 to KSh 4,133.8 billion as at end of June 2021. Net foreign assets reduced from KSh 887.4 billion as at end of June 2020 to KSh 781.9 billion as at end of June 2021. The Central Bank Rate (CBR) remained at 7.00 per cent during the review period. The Treasury bill rate decreased from 7.14 per cent in June 2020 to 7.03 per cent in June 2021. Lending rate and interbank rate increased from 11.89 per cent and 3.27 per cent in June 2020 to 12.02 per cent and 4.63 per cent in June 2021 respectively. On the contrary, average deposit rates and savings rate decreased from 6.86 per cent and 4.15 per cent in June 2020 to

6.37 per cent to 2.55 per cent in June 2021.

**Figure 2: Trends in interest rates, January 2020 to June 2021**

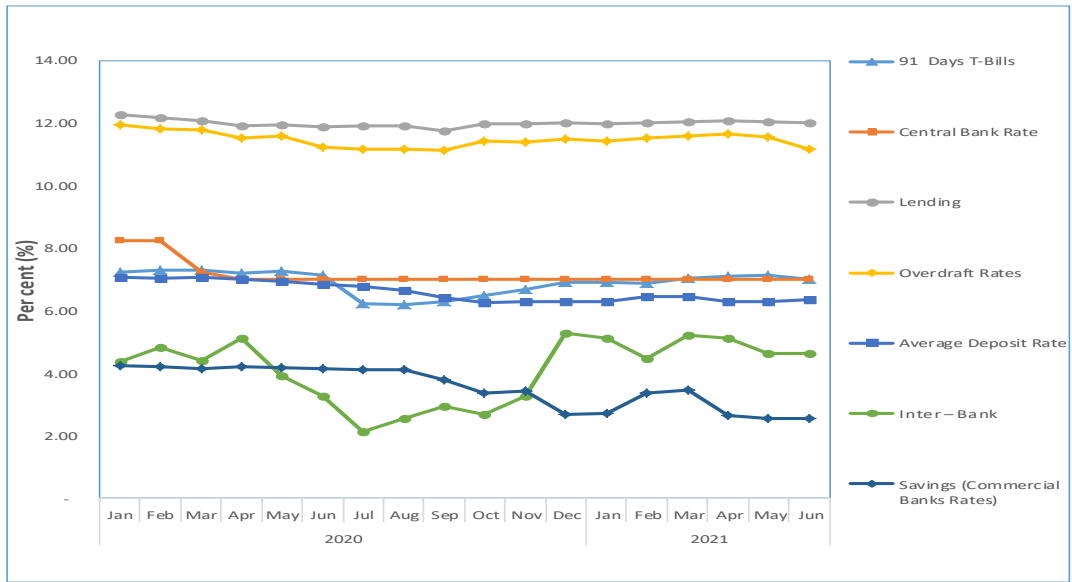


Figure 3 shows the value of shares traded and the NSE 20 share index January 2021 to June 2021. The Nairobi Stock Exchange (NSE) 20 Share index decreased from 1,942 points in June 2020 to 1,928 points in June 2021. The total value of shares traded increased from KSh 12.3 billion in June 2020 to KSh 14.0 billion in June 2021.
