Third Quarter, 2022

Balance of Payments

Table 1 presents the country's quarterly Balance of Payments statistics for the period, September 2020 to September 2022. The current account deficit expanded by 5.5 per cent from KSh 183.4 billion in the third quarter of 2021 to KSh 193.4 billion in the corresponding quarter of the period under review. During the third quarter of 2022, merchandise trade deficit widened to KSh 373.1 billion from KSh 322.0 billion in the third quarter of 2021, an increase of 15.8 per cent. Export earnings grew by 29.7 per cent to KSh 228.2 billion while the import bill increased by 20.8 per cent to KSh 601.2 billion over the same period. The increase in import expenditure was largely due to growth in imports of petroleum products during the quarter under review, despite the sustained reduction in the price of crude oil in the global market in the preceding months. Murban oil prices per barrel reached USD 82.26 on September 27 from a high of USD 130.24 on March 9. Increased export earnings from tea was the main driver in growth of exports.

Receipts from international trade in services went up by 66.0 per cent while services payments increased by 46.0 per cent during the review period. Consequently, the balance in international trade in services more than doubled from a surplus of KSh 22.5 billion in the third quarter of 2021 to a surplus of KSh 59.2 billion in the corresponding quarter of 2022. Receipts from transport and travel services continued to support the surplus in trade in international services. Diaspora remittances remained resilient, increasing by 7.7 per cent to KSh 114.3 billion in the third quarter of 2022 despite a decline in quarterly flows reflecting seasonality.

In the third quarter of 2022, net financial inflows increased by 13.4 per cent to a surplus of KSh 190.8 billion from a surplus of KSh 168.3 billion in the corresponding quarter of 2021. Inflows of other investment remained the main source of external financing which included a loan from the International Monetary fund received in July 2022. During the quarter under review, there was draw down in gross official reserves towards servicing of public external debt, which has continued to

increase over the years. As a result, the stock of gross official reserves reduced by 11.7 per cent to KSh 940.2 billion in the third quarter of 2022 from KSh 1,064.2 billion in the same quarter of 2021. This led to the deterioration of the overall Balance of Payments position to a deficit of KSh 112.7 billion in the third quarter of 2022 from a deficit of KSh 29.3 billion in the same quarter of 2021.

Stock of External Debt Liabilities of General Government

The stock of external public debt liabilities stood at KSh 4,272.1 billion at the end of September, 2022. This represented an 8.5 per cent increase from KSh 3,937.9 billion recorded at the end of September, 2021 as presented in Table 2. The stock of external debt largely comprises of loans, which accounted for 78.9 per cent of the stock of external public debt of General Government at the end of September 2022. External loans from multilateral lenders rose by 15.9 per cent and accounted for the bulk of external debt of KSh 1,973.4 billion as at September, 2022.

The stock of debt securities attributable to General Government similarly rose during the period under review from KSh 820.2 billion at the end of September, 2021 to KSh 902.7 billion at the end of September, 2022. The International Sovereign Bond, which is the main component of debt securities, rose from KSh 784.5 billion in September, 2021 to KSh 870.7 billion at the end of September, 2022, largely on account of exchange rate valuation. The stock of Treasury Bonds similarly rose by 9.4 per cent over the same period.

International Merchandise Trade

In the third quarter of 2022, trade balance widened to a deficit of KSh 434.0 billion from a deficit of KSh 366.1 billion recorded in the third quarter of 2021, as shown in Figure 1 and Table 3. During the review period, total exports increased by 29.7 per

cent to KSh 227.8 billion while imports increased by 22.2 per cent to KSh 661.8 billion. The growth in export earnings was mainly occasioned by increase in domestic exports of tea, which rose by 45.5 per cent. The growth in import bill was largely driven by a significant increase in imports of petroleum products, which more than doubled from KSh 82.3 billion in third quarter of 2021 to KSh 182.6 billion in the third quarter of 2022.

Figure 1: International Merchandise Trade Balance, 3rd Quarter, 2020-2022

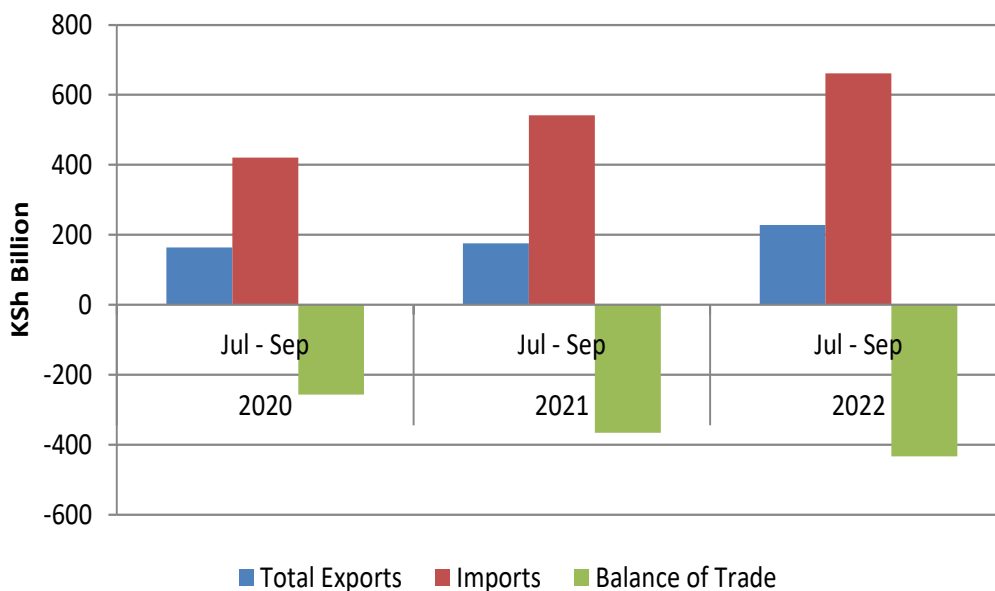

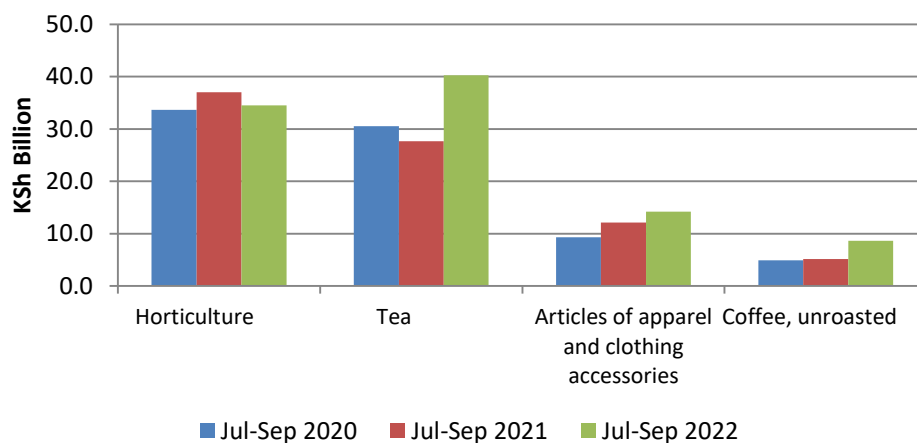
Value of Domestic Exports

During the third quarter of 2022, revenue from domestic exports was valued at KSh 200.5 billion, reflecting an increase of 25.4 per cent from the corresponding quarter of 2021. This was largely driven by increased domestic exports of tea; coffee; and animal and vegetable oils which jointly accounted for 47.0 per cent of the increase as presented in Annex 1 and Figure 2. Earnings from domestic exports of tea recorded an increase of KSh 12.6 billion from the third quarter of 2021. This was largely attributable to an increase in export quantities coupled with improved tea prices in the international markets. The price of tea increased from KSh 221.7 per kilogramme in the third quarter of 2021 to KSh 293.8 per kilogramme in the third quarter of 2022.

The value of domestic exports of unroasted coffee increased from KSh 5.2 billion in the third quarter of 2021 to KSh 8.7 billion in the third quarter of 2022, while revenue from domestic exports of animal and vegetable oils almost doubled, over the same period. Other commodities that contributed to the increase in export earnings were articles

of apparel and clothing accessories (16.9%), iron and steel (43.1%); and organic and inorganic chemicals (83.8%). On the contrary, income from domestic exports of horticultural products declined by 6.7 per cent to KSh 34.5 billion in the third quarter of 2022 compared to the corresponding quarter of 2021.

Analysis by Broad Economic Category (BEC) classification show that primary food and beverage category had the largest share of domestic export earnings in the third quarter of 2022 contributing 42.1 per cent to the total domestic export earnings, as depicted in Annex 7. Domestic exports of non-food industrial supplies increased by 36.8 per cent from KSh 42.7 billion in the third quarter of 2021 to KSh 58.4 billion in the quarter under review.

Value of Imports

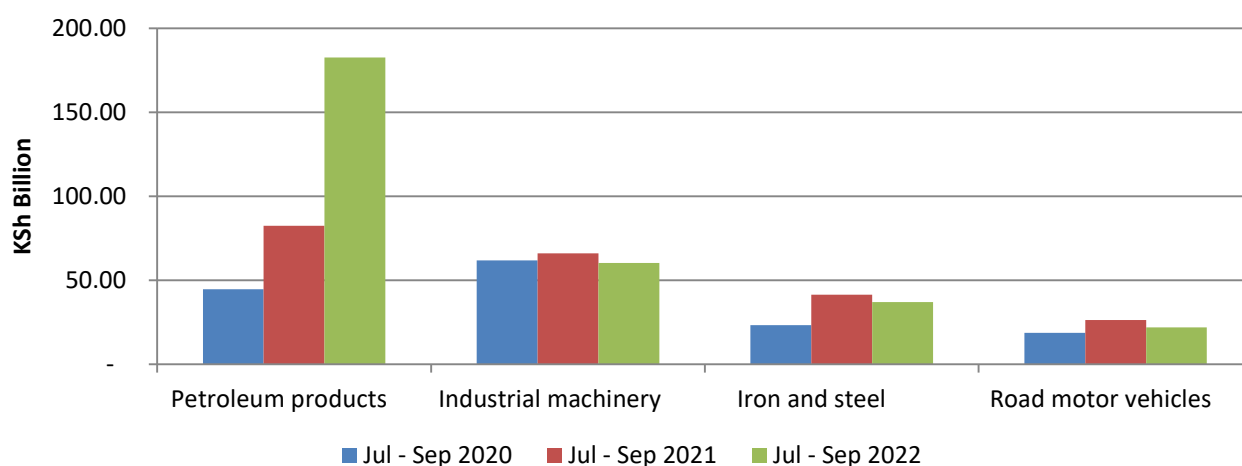
Expenditure on imports rose from KSh 541.8 billion in the third quarter of 2021 to KSh 661.8 billion in the third quarter of 2022. The significant growth was largely attributable to an increase in imports of petroleum products and chemical fertilizers which more than doubled during the period under review, as shown in Figure 3 and Annex 3. The value of imported petroleum products rose from KSh 82.3 billion in the third quarter of 2021 to KSh 182.6 billion in the third quarter of 2022 while that of imported chemical fertilizers rose from KSh 8.0 billion to KSh 12.6 billion, over the same period.

Despite decreases in quantities of imported unmilled wheat; and animal and vegetable oils in the quarter under review, their corresponding import value rose by 24.3 per cent and 15.2 per cent respectively, compared to the same quarter of 2021

as illustrated in Annex 3 and Annex 4. Similarly, there were notable increases in the value of imported maize; and medicinal and pharmaceutical products from KSh 7.0 billion and KSh 21.4 billion in the third quarter of 2021 to KSh 10.9 billion and KSh 24.7 billion, respectively. In contrast, the value of imported industrial machinery; iron and steel; and road motor vehicles declined by 8.9, 10.8 and 16.7 per cent, respectively.

Under the Broad Economic Category (BEC) classification, the bulk of import expenditure in the third quarter of 2022 was attributable to non-food industrial supplies, accounting for 36.2 per cent of the total import bill. Notably, there was a significant increase in the value of imported fuel and lubricants from KSh 99.1 billion in the third quarter of 2021 to KSh 196.3 billion in the period under review, as shown in Annex 8.

Direction of International Merchandise Trade

In the third quarter of 2022, total exports amounted to KSh 227.8 billion rising from KSh 175.7 billion in the third quarter of 2021, translating to a growth of 29.7 per cent as presented in Annex 5. Notably, total exports earnings from Africa registered the highest increase from KSh 74.1 billion in third quarter of 2021 to KSh 97.6 billion in the quarter under review, representing a growth of 31.7 per cent. Domestic exports of palm oil to Uganda, tea to Egypt; and palm oil, chemical fertilizers and stoves to Rwanda, partly contributed to the increase in export earnings from the region. However, over the same period, the value of total exports to Ethiopia recorded a 20.0 per cent decline, majorly arising from decreased domestic exports of food preparations for infants.

Revenue from exports to the European Union increased from KSh 26.8 billion in the third quarter of 2021 to KSh 32.3 billion in the third quarter of 2022. This was largely boosted by an increase in domestic exports of coffee to Germany and re-exports of kerosene type jet fuel to the Netherlands. Moreover, export earnings from Asia increased by 41.8 per cent to KSh 54.0 billion in the third quarter of 2022 compared to the corresponding quarter of 2021. This was majorly driven by an increase in domestic exports of tea to Pakistan and the United Arab Emirates. Similarly, growth in domestic exports of coffee and articles of apparel and clothing accessories resulted to a 39.4 per cent increase in export earnings from the United States of America.

Expenditure on imports in the third quarter of 2022 amounted to KSh 661.8 billion, reflecting an increase of 22.2 per cent compared to the same quarter of 2021, as highlighted in Annex 6. Asia remained the largest source of imports in the quarter under review, accounting for 68.6 per cent of the total value of imports. There was a marked increase in imports of gas oil and motor spirit (gasoline) premium from the United Arab Emirates and Oman, which drove the increase in imports from the Middle East from Ksh 93.1 billion in the third quarter of 2021 to KSh 168.1 billion in the third quarter of 2022. In contrast, the value of imports from Saudi Arabia declined by 34.2 per cent to KSh 23.0 billion partly on account of decreased imports of gas oil.

In relation to the Far East, there was a surge in imports of kerosene jet type fuel from South Korea; crude palm oil and motor spirit (gasoline) premium from Malaysia which accounted for the growth of import expenditure in the third quarter of 2022.

The value of imports from the European Union dropped from KSh 66.0 billion in third quarter of 2021 to KSh 62.6 billion in the corresponding quarter of 2022, translating to a decline of 5.1 per cent. In spite of the reduction in imports from this trade bloc, the value of imports from the Netherlands went up by 69.7 per cent partly due to increased importation of motor spirit (gasoline) premium.

During the third quarter of 2022, expenditure on commodities imported from Africa rose by 29.9 per cent to KSh 76.9 billion compared to the corresponding quarter of 2021. This was driven by increased imports of coal and; iron and steel from South Africa. Similarly, the import bill from Australia rose from KSh 3.3 billion in the third

quarter of 2021 to KSh 5.6 billion in the quarter under review, resulting from increased imports of wheat and meslin.

On the other hand, import expenditure from America declined from KSh 33.5 billion in third quarter of 2021 to KSh 31.1 billion in third quarter of 2022 partly on account of decreased imports of helicopters from the United States of America.
